


FITTING INSTRUCTIONS FOR BLP0051BK REAR FOOTREST BLANKING PLATES FOR HONDA CRF 1000L AFRICA TWIN '16-



THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)





Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

TOOLS REQUIRED

• 5 & 6mm metric Allen key.

Fitting Instructions

- Remove the two bolts that secure the OEM pillion footrests in place on both side of the bike. The footrest hangers should now come away from the bike.
- Fit two bolts through either blanking plate and offer up to the bike, before tightening.
- Repeat the above process to fit the blanking plate to the other side of the bike, ensuring the logos are the correct way up.
- Ensure all bolts are tightened evenly.



Notice de montage

- Enlever les 2 boulons qui fixent les repose pieds du passager en place des 2 cotés de la moto. Les supports de repose pied devraient s'extraire de la moto à présent.
- Insérer les 2 boulons dans une des plaques d'obturation puis montez la sur la moto, avant de serrer.
- Répéter le process ci-dessus pour monter la plaque d'obturation de l'autre coté de la moto, en veillant à ce que les logos soient orientés du bon coté.
- Vérifier que tous les boulons soient correctement serrés, de façon identique.
