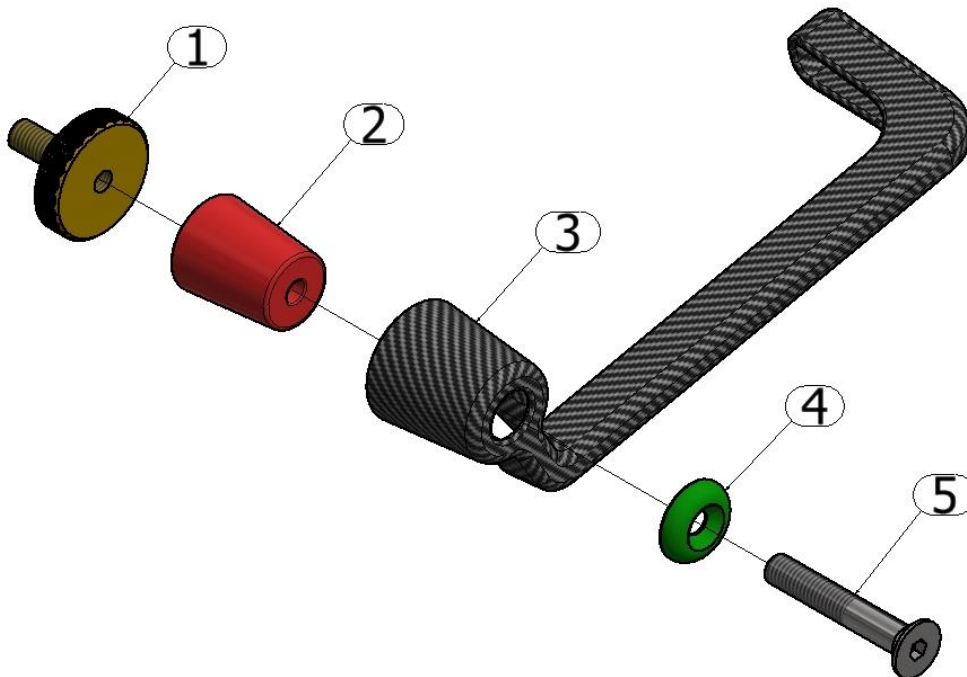

ITEM 1 = MOUNTING BOSS (M0542) (x1)

ITEM 2 = LARGE CONE SPACER (S0781) (x1).

ITEM 3 = CARBON FIBRE LEVER GUARD (NOT INCLUDED IN FITTING KIT) (LG0001).

ITEM 4 = CLAMP SPACER (S0928) (x1).

ITEM 5 = M6 x 50mm LONG COUNTERSUNK BOLT (x1).

TOOLS REQUIRED

- Set of Allen keys to include 4mm A/F.
- Any tools required to remove original bar-end if applicable.

FITTING INSTRUCTIONS

- To fit the Lever Guard (item 3), remove the original bar end.
- Mount the protruded end of the mounting boss (Item 1) into the threaded boss in the handlebar. Fully tighten the mounting boss in position.
- Place the counter-sunk bolt (item 5) through domed counter-sunk spacer (item 4) and then through the Lever Guard so the domed spacer sits against fixed spacer in the Lever Guard.
- Place the large cone spacer (item 2) over the thread and into the Lever Guard.
- Locate the lever guard assembly into the threaded hole on the mounting boss (item 1) just fitted and position so when the motorcycle is at full lock in both directions it does not contact any other part of the motorcycle.
- Ensure that the assembled components match the exploded diagram shown in page 1.
- Fully tighten the bolt and check operation.

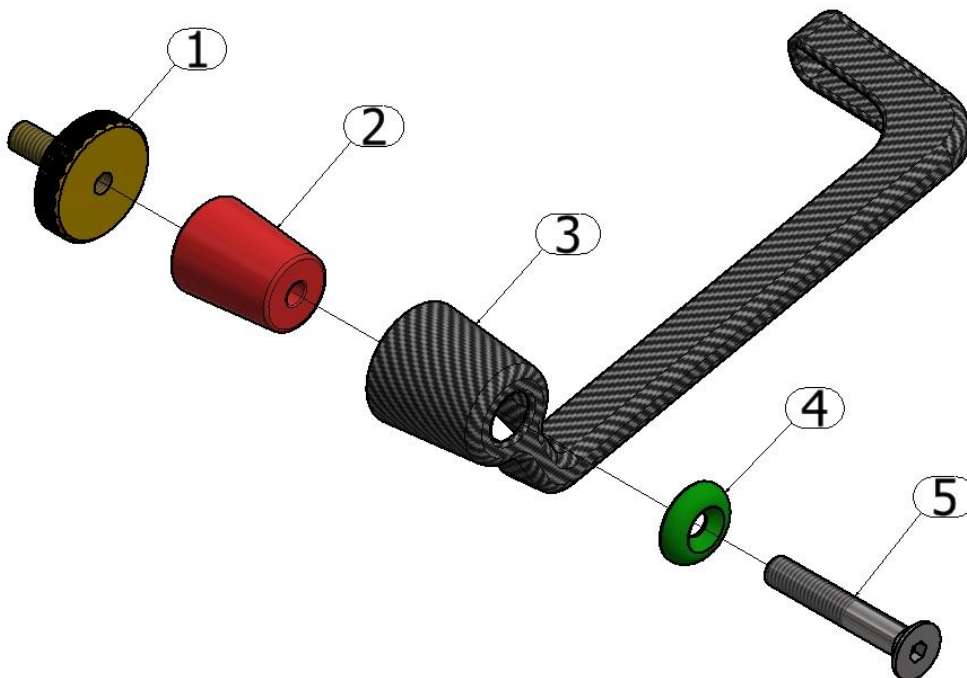

- Monter l'extrémité dépassant du filetage de fixation (article 1) dans le filetage du guidon. Serrer complètement en position.
- Placer le boulon (article 5) dans l'entretoise (article 4) puis dans la protection levier de façon à ce que l'entretoise se place contre l'entretoise de la protection levier.
- Placer l'entretoise conique (article 2) sur le filetage puis dans la protection levier.
- Monter l'assemblage de protection levier en place dans le trou du filetage de fixation (article 1) tout juste monté puis positionner de façon à ce que lorsque le guidon est tourné au maximum d'un côté ou de l'autre, aucune partie ne soit touchée.

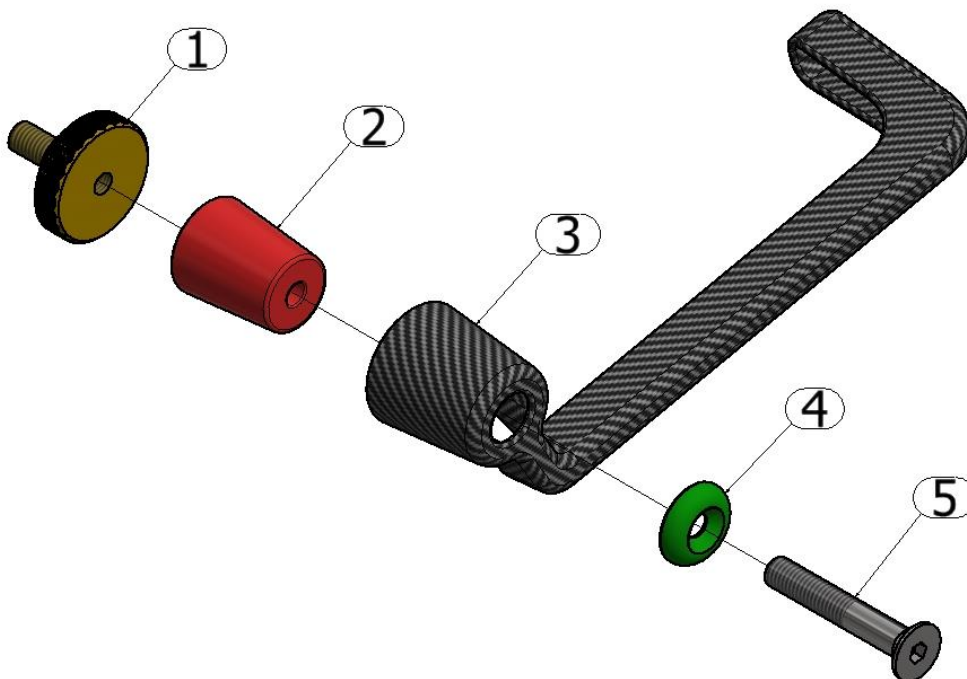

- Um den Bremshebelschutz (Artikel 3) zu montieren, entfernen Sie das original Lenkerende.
- Das hervorstehende Ende des Distanzhalters mit Gewinde (Artikel 1) am Gewindeeinsatz am Lenker montieren. Den Distanzhalter in Position befestigen.
- Führen Sie die Senkkopfschraube (Artikel 5) durch den Distanzhalter (Artikel 4) dann durch den Bremshebelschutz, so dass der Distanzhalter am fixierten Distanzhalter im Bremshebelschutz anliegt.
